### Other Information:

# <u>Cornwall Community Hospital – Deena Shorkey</u>

- Ramping up stage of work. PPE has been ordered and have started doing in person psychological assessments.
- Next week in person play therapy will begin.
- Virtual Post-partum Group starting next week.
- Referral still at low volumes but seems more complex (15 referrals and all youth with suicide ideation).
- Virtual appointments will continue with clients who it is working well for.
- Parents Psycho-educational Groups will begin with parents on how to prepare their children to return to school.
- Group, group loss and the impact on youth.
- A live chat was held with the mayor about the importance of services and to encourage the community to reach out.

# IV. Department Update

Professional development has continued over the last few weeks. Pat Cole shared her expertise on the Social Skills Programs that we offer to the students throughout the Board. This generated an increased interest for support staff who hope to be able to co-facilitate these programs in the future. Krista Kiiffner and Pat Cole delivered information on anxiety the following week, with an emphasis on strategies to use when students struggle with anxiety. Pat finished the week talking about the Hidden Curriculum and how this impacts students with an Autism Spectrum Disorder. This week Janet Carioni is teaching the staff about the sensory needs of our students and how we can support these needs in the general classroom and throughout the school. All the professional development noted above has been offered to Teachers, Early Childhood Educators and administrators and has been well received. The Student Support Workers and Itinerant ABLE Workers have been taking part in meetings to learn more about the "Duty to Report".

"The Science of Reading" and how our brain learns to read has been presented to many school teams throughout the Board. The first session focused on how kids learn to read and the important role that phonological awareness and phonics play in word-level reading. They shared how to align teaching practices with how the brain learns to read. The second session concentrated on shifting our focus from letters (visual) to sounds (auditory), which falls in line with how we learn to read and makes teaching phonics and phonemic awareness run more smoothly. This session also focused on shifting the way we teach kids to learn high-frequency words to align with how the brain learns to remember words. Words are divided into three types of high-frequency words, from the most easily decoded, to the most irregularly spelled.

Example routines were explored. Teachers and support staff are excited to put what they have learned into practice.

The Department received positive feedback from the Educational Assistants after the job placement took place virtually. This will probably continue to happen virtually in the future.

## Summer Learning Program

The Ministry allocated money for the following priorities:

- Responding to crisis situations.
- Supporting special needs students who are presently on our caseload.
- Special education funding to hire SERTS and Educational Assistants.
- An in-person transition back to school program for special needs students two weeks prior to school opening.
- The expansion of the Summer Learning Program (K-8) for 618 students. Forty teachers and forty Educational Assistants have been hired.
- A Lead Consultant from Special Education and the Principal of Curriculum will oversee this.

The Summer Learning Program will run from July 6-24, 2020 for six hours a day. Two of those hours will involve a synchronous learning component. The other four hours will focus on working with smaller groups of students, parent engagement, feedback and assessment.

CDSBEO is also offering their regular e-learning programs this summer, 907 students have registered from Grades 9-12.

The Mental Health Team and the Psychology Department will continue to conduct assessments, mental health check-ins and virtual support to parents. Our ABA Consultants will continue to support ASD students and Mental Health Addictions Counselors will continue to provide support working in collaboration with our Community Partners.
