Mrs. Hutchinson, Mr. Loshaw, Ms. Crawford, Ms. Hunt and Mr. Bosch presented the PowerPoint Presentation virtually to participants in a combined fashion. Presenters spoke about their respective board data and provided the opportunity for participants to ask question.

Q&A:

Participants were provided a question/comment period following the presentation. The Q&A is listed below.

Question #1:

Difference in space utilization between the UCDSB and the CDSBEO.

Response:

The goal is to balance enrolment to ensure we do not underutilize or overpopulate a school. School location would be a factor.

Question #2:

Projections and planning through net migration?

Response:

UCDSB Planning Department looks at this information and how it changes by age cohort each year. CDSBEO engages external consulting firm to assist with data as the Board does not have a robust Planning Department.

Question #3:

While portables are not the most ideal form of classrooms, is there opportunity for one board to be using space at a neighbouring school of another board (even a few hundred metres away) that is experiencing a surplus of space?

Response:

If a situation present itself, UCDSB & CDSBEO would be open to conversing with one another and would follow board process.

Question #4:

Will there be a more comprehensive review of the long-term projections?

Response:

CDSBEO is looking at accommodation plans for the next 5 years.

Question #5:

Do you anticipate boundary review in areas where there is sufficient growth, such as the Kemptville area (Oxford on the Rideau Public Elementary School)?

Response:

UCDSB has no current plan to change boundaries in the Kemptville area.

Question #6:

- a) Do you have a position on proposed Bill 98, Better Schools and Student Outcomes Act, 2023? More specifically, in regard to framework related to partnerships between municipalities and school boards?
- b) Do you anticipate changes to board policies/procedures related to this proposal?
- c) Any specific concerns related to Bill 98?

Response:

(Prior to Royal Assent of Bill 98) UCDSB stated the Government of Ontario has expressed that boards will have the opportunity to shape these decisions. At this point, we do not have specific details on the outcome of what Bill 98 will look like. No concerns at this point. CDSBEO expressed that both boards are more than happy to work with our municipalities/community partners. Nothing additional to add at this point regarding Bill 98.
