<p>Topic: Promoting Mental Health Facilitators: Selina Mackie – CDSBEO Mental Health Lead Strategist Location: Virtual Targeted Audience: All Teachers, EAs, ECE's, SSWs, Chaplain Leaders, and IAWs. Description: Research shows that difficult school transitions can result in a decline in grades, a decrease in school engagement, feelings of loneliness and isolation, and increased stress. Yet not all feelings about school transitions are challenging. This presentation will highlight why school transitions might cause stress and offers educators and support staff ways to support students to recognize feelings of trepidation as normal while equipping them to navigate stress and embrace the change as a time of excitement and growth.</p>
