CDSBEO and UCDSB presenters walked participants through a virtual PowerPoint Presentation in a combined fashion. Presenters spoke about their respective board data and provided the opportunity for participants to ask question.

Q&A:

Participants were provided a question/comment period following the presentation. The Q&A is listed below.

Question #1:

What opportunities exist for partnering with organizations, such as private schools, to help school boards achieve their space utilization goals?

Response:

School boards have the authority to make decisions regarding their school facilities and the use of their properties that are consistent with the Education Act and the Community Planning and Partnership Guidelines, where applicable.

Question #3:

Would school boards consider the idea of school boards and Consolidated Municipal Service Managers (CMSM) jointly engaging with the Ministry of Education to discuss potential solutions for expanding childcare spaces in our area? Leeds and Grenville CMSM is interested in pursuing this initiative.

Response:

CMSM should have a discussion with the Early Years Superintendent at each school board.

Question #4:

Should municipalities be worried that schools identified with having surplus spaces might face closure if the moratorium on school closures is lifted?

Response:

No plans currently for CDSBEO or UCDSB.

Question #5:

Glengarry Inter-Agency Group Inc. – The Learning Centre has recently decided to eliminate part-time opportunities for before/after school childcare programs. Do you anticipate this will affect their community partnership application for space utilization in schools for the upcoming school year?

Response:

Childcare operators do not occupy school space by way of Community Use of Schools permits. Instead, lease agreements are in place with all licensed third-party childcare providers.

Question #6:

Does either school board have plans to amend school boundaries?

Response:

No current plans for CDSBEO or UCDSB.

Question #7:

Reflecting on enrolment trends, are you seeing numbers above or below projections?

Response:

Overall, boards are currently experiencing stable to upward enrolment trends, which is different than 10-15 years ago when it was more downward. This trend of course does vary dependent on the school, programs offered and the number of school boards active in the same area. Both boards cover a very large geographic area and have, in more recent years, experienced unexpected increases in enrolment compared to enrolment projections in higher growth areas, typically within closer proximity to Ottawa.

Question #8:

How are housing starts, and community growth plans used by school boards?

Response:

School boards can use housing starts and community growth plans to support long term planning for future student accommodation needs. Projected housing starts provided by municipalities can be incorporated into longer term enrolment projections based on the estimated number of students, or student yield, that different types of housing can provide to a school in a board. Student yields can be calculated based on actual housing starts.

Along with information such as immigration policy changes, tracking actual housing starts can also signal changes in overall growth for the community and how it compared to initial expectations.

Question #9:

Do school boards collaborate with municipalities on project planning?

Response:

When there are future projects planned at boards, there are ongoing conversations with municipalities and third-party childcare partners. When planning for new schools and additions, CMSM's are consulted to determine if there is interest in new or expanded childcare facilities as part of the Capital Priority request. School Boards consult with municipalities throughout the planning process of capital projects through the site plan control, zoning and permitting processes. UCDSB provided several examples where municipal collaboration was key in the process of generating ideas for large capital projects. In some cases, either municipal or school board constraints on projects such as timelines or cost, can limit the extent of the collaboration.

Question #10:

Do School Boards regularly submit comments to municipalities/planning approval authorities when subdivisions are proposed?

Response:

School boards receive a large quantity of municipal planning correspondence. UCDSB staff submit comments to municipalities regarding subdivision development proposals when there is an issue to clarify or comment on. One example might be to identify a potential safety issue for students who would reside in a new subdivision and who would be attending a nearby school. This might include providing comments or questions regarding the planning of sidewalks and/or crosswalks that align with existing school entry.

Question #11:

Are there any plans for UCDSB and CDSBEO to collaborate in sharing school spaces in communities where there is surplus space in one area of the board and substantial enrolment in the other?

Response:

No specific plans in this area at this stage

Question #12:

Would a CMSM also be included in that conversation to discuss childcare in the new construction?

Response:

This is the current practice at the CDSBEO and UCDSB.

Question #13:

For future meetings, could a recording or transcript of the meeting be provided so that we may easily share with municipal staff and council who were not able to participate.

Response:
